MOFM Chaplains Ministerial Services

Our Ordained Chaplains are trained in religious studies and pastoral care throughout the year. With emphasis on Services such as Weddings (must be licensed by Clark County Clerks Office), Funerals, Baptisms,

Chaplaincy Trains: individuals for Lay Chaplaincy (non clergy) and Ordained Chaplains (professional clergy) opening its door 2 times per year to new individuals. People apply from numerous churches and organizations across Nevada. All classes and materials are free to attend and receive at no cost to the individual. Chaplaincy is a faith-base community service for Christ. Chaplaincy has graduated up to 400 Lay Chaplains and ordained over 200 Chaplains from 2009 to current status.

Volunteer Hours: are recorded from the Chaplains Administration Dept, headed by our Director of Administration. This dept keeps track of all data information and transcripts. From the Chaplaincy inception of October 2009 to current status Chaplaincy has over 200,000 volunteer hrs. Recognized by the NV State Governors Office, CLV Mayors Office, Clark County Commissioners, and the Office of the White House President Faithbase Initiatives.

Chaplaincy Volunteers: and teams of Chaplains serve in the hospitals, hospice, CCSD, prisons, CCDC, RECAP, Mayors Faith Forum, Re-entry, Juveniles, and more.
