#### RELIGIOUS EDUCATION & TRAINING CURRICULUM

#### Introduction

Chaplaincy Nevada training is biblically based, which emphasizes Christ as the central figure and paradigm for all Christianity. Chaplains Certification and Academy studies and materials are endorsed after satisfying its specific education and training objectives outlined by the authority of Messages of Faith Ministry, E.D. and governing Chaplains body, of religious trainers. Chaplain Academy Body of Members must be Professionals in Education, Training, Pastors, Assoc. Pastors, Elders, Sr. Chaplains, and Licensed Psych./Counseling.

Preamble: Chaplaincy is grounded in initiating, developing, discipling, and bringing an appropriate amount of education and training under Messages of Faith Ministry, and its Chaplaincy Nevada division through the Academy and Basic Religious Studies. This includes Religious Studies and further education, Professional trained Overseer's, Teamwork and Collaboration, Ethical Practice which guides decision making and professional behavior, Confidentiality which respects the privacy of chaplains personal and educational information.

Religious Education Curriculum has been described at each phase level: 1, 2, and 3.

The intent of this curriculum is to identify core religious education and training concepts for each level and to articulate the information in easy language.

The structure of these phases is based on the triune God (God the Father, God the Son and God the Holy Spirit) and the purpose driven life for those that are called to serve as chaplains.

- 1. We believe that there are five steps that are followed to have and encounter with God, like Isaiah did in Isaiah6:5-8:
- 2. Be convicted of sin.
- 3. Repentance of sin.
- 4. Being cleansed by God.
- 5. Being called by God.
- 6. Respond to God's call to feed His sheep.

It is our hope that this Grade Specific Religious Education Curriculum provides concise descriptors that identify what is to be learned and lived as we share the treasure of our faith with the children of God, on a life-long journey of being disciples for Christ.

#### STATEMENT OF FAITH

- 1. We believe the Bible to be the inspired, the only infallible, authoritative Word of God.
- 2. We believe that there is one God, eternally existent in three persons: Father, Son, and Holy Spirit.
- 3. We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in Hisvicarious and atoning death through His shed blood, in His bodily resurrection, in His ascension to the right hand of the Father, and in His personal return in power and glory.
- 4. We believe that for the salvation of lost and sinful people, regeneration by the Holy Spirit is absolutely essential.
- 5. We believe in the present ministry of the Holy Spirit by who's indwelling the Christian is enabled to live a godly life.
- 6. We believe in the resurrection of both the saved and the lost; they that are saved unto the resurrection of life and theythat are lost unto the resurrection of damnation.
- 7. We believe in the spiritual unity of believers in our Lord Jesus Christ.

#### CURRICULUM OVERVIEW AND PROMOTION REQUIREMENTS

Cost: There are no incurred costs for any level of training, upon validation.

Chaplain members and students pay for their own merchandise, i.e. uniform polo, ID, pins, etc.

Class Location: Metro Plex Complex Bldg. A

Course/Class: Training is conducted January through December.

Transcripts: Your Transcripts are in Excel format and filed within the Administration Dept. database.

Certificates: Are presented upon Graduations.

Specialty classes/partnered trainings may be the exception to the rule.

#### Requirement to be a Lay Chaplain

Level 100 – Basic Chaplaincy

- 24 hour certificate program.
- Must complete and online application and submit it at least two weeks prior to the start of class.
- Must pass the Basic Chaplaincy course/exam.
- Students receive a MOFM Lay Certificate upon completion of this course.

#### Requirement to be an Ordained Chaplain

Level 200 – Chaplain Ordination

- ➤ 36 total hour training Basic/Ordination program.
- Must be called by God.
- Must pass Basic chaplaincy course Level 100.
- Must review the Ministry Protocol for Chaplains
- Must submit a Letter of Recommendation from a Pastor or a religious leader of the church.

#### Requirement to be a Senior Chaplain

Level 300 – Chaplains Academy

- ► 12 to 24 month Academy religious training program.
- Must complete Level 100 and Level 200 courses and Level 300.
- Must volunteer a minimum of 8 hours of Chaplain/church/community volunteer work.
- Must submit a Graduation request and essay prior to SR Chaplain Graduation (held twice a year).
- Students receive a Ministry Senior Chaplain Graduate certificate upon completion of Levels 100, 200,
- ▶ 300 and submission of a 2,000-word autobiography on, "Your Journey of Faith".

#### Requirement to Attend Non-Academy Classes

Level 400 – Specialty Courses

Must be a Messages of Faith Ministry Chaplain (lay/ordained).

#### Requirement for Seminary Professional Certificate Graduate

Level 500 – Seminary

Must complete all required classes. Must complete 2500 Word Essay "My Philosophy & Christian Faith"

#### Requirements for Board Certified Chaplain Graduate

Level 600--

# STANDARD CLASSROOM/REGISTRATION POLICIES All Training is conducted under Academy

- To register for any and all classes/programs you must follow the classroom and registration policies.
- 1. Must attend all required sessions per class to complete, unless provided with an approved notice, or assignment make-up.
- 2. Must attend sessions on time and in a timely manner (15 minutes prior to session). Students arriving more than 1 hour late for class will be required to retake that session. If you're going to run late contact your instructor prior to class.
- 3. Must follow standard code of conduct for chaplains: See website: chaplaincynevada.org/Advisory-Board.
- 4. Must provide updated contact information if there is a change.
- 5. Must properly sign up for sessions with Registration by replying back to each registration email. Walk-ins are not accepted for particular sessions unless you receive prior validation by the Academy.
- 6. Must return seats and chairs to their proper location at the end of each session/class and throw away your trash.
- 7. Due to allergies and sensitivity to smells by other students and instructors, excessive perfumes and essential oils are not allowed in class. During times of Cvd-19 follow cdc guidelines. Please stay home if sick.
- 8. Must provide a 250-word essay on an approved topic by class instructor, if you miss a required session/class. Missed classes/assignments you must use standard format for essay (Title, Intro, Body, Conclusion) and it must be typed. Each class allows a specific number of missed classes due to employment/illness/out of town. Please contact your instructor.
- 9. Habitual class cancelation may lead to grounds for suspension of class registration. Do not continually register for classes and drop/ or be recorded as a no-show. You will be notified after 3 classes of no-show. Contact registration if you must drop a class prior to the start date and not after materials are sent out. Materials are provided to those who are expected to attend and complete training.
- 10. You must register for classes with the registration dept. and not instructors. Instructors may not drop students from class after they have registered, only registration may legitimately drop students from the class.
- 11. It is the responsibility of each student to come prepared for each class. For students who suffer from disabilities please inform your instructor of your disability, and to receive proper accommodation to be made for your comfort.
- 12. You must dress appropriately in the classroom. No "shorts", knee/ankle length is a must.
- 13. Reminder: The training facility is within LVMPD Headquarters. Respect, courtesy, and room cleanliness is important in the partnership of MOFM and LVMPD. The training rooms are not a church, and therefore training courses are conducted in the premise of an educational academy. Praying in and praying out is under the authority of the instructor for each class, do not interrupt the classes for personal prayer time of one another. The area of the lobby is under the guidance of law enforcement please keep it clean and quiet as many are working within their offices on weekdays and weekends.
- 14. Do not interrupt classes for personal purposes. Classes are not to be conducted for personal therapy sessions. Questions that do not pertain to the subject matter please see your instructor after class. Please do not take up your fellow chaplains learning time to debate, argue, or go off track of the subject matter.
- 15. Request for transcripts is only accepted by email or in writing. Transcript requests are through the Administration dept. and not Academy. You may contact your Admin Team member to request a transcript.

### • Ministerial Professional Board-Certified Chaplain Graduate.

The Board Certification implies that the chaplain has gone above and beyond that minimal standard of ministerial specialty by way of additional education and study and has passed a trial/examination to demonstrate it.

Professional certification is proof of achievement awarded to someone for completing a training program that qualifies them to perform a Chaplaincy service and/or job. Like any qualification, professional certification involves extensive study and an acquirement of understanding/knowledge.

Board certification is the process by which one acquires and can professionally demonstrate a basic knowledge, and skills through written, practical, class lab/testing, in-field service, hours, and merit. Certification is important because it assures you that the Chaplain skills, integrity, and experience have been carefully scrutinized by the ministry board of experts, and leaders, and found to be exceptional. Board certification is the process by which chaplain candidates demonstrate their competence, and ability to function as a professional chaplain in servantry and community in a professional chaplaincy manner and excellence.

The role of a Chaplain is to provide "emotional, spiritual, religious, pastoral, ethical, and/or existential care" in a religious or secular setting.

Messages of Faith Ministries is a non-denominational Christian Ministry, licensed since 2001 NV State Incorporated, and a Federal 501c3 since 2001, by whose bylaws reflects one of its main objectives is to establish religious education, training, and certifications.

Board Certified Chaplains graduate under the approval of the Ministry Ordained Professional Clergy Educational Board.

There is no accreditation or licensing requirement for any religious schools, seminary, academy, etc. Religious school accreditation or licensing is optional. Only Non-religious, private schools must be either licensed or accredited. Accreditation in the USA is purely a voluntary process and is NOT required for any religious studies. MOFM is a no-fee Christian Chaplain training academy
